

**MINUTES OF THE MEETING HELD ON 06-07—2017 IN THE OFFICE
CHAMBER OF THE DISTRICT AND SESSIONS JUDGE, NAGAON.**


In compliance of ORDER-24 & 52 of the Hon'ble Gauhati High Court, Guwahati, the monthly meeting for the month of July, 2017 is held today, i.e. on 05-07-17 in presence of the Addl. Deputy Commissioner, Nagaon and the Superintendent of Police, Nagaon and participants have conversed about causes leading to delay in investigation and trial and also assessed the progress of agenda of last meeting.

In today's Meeting the following points have been discussed:-

1. In the meeting the Superintendent of Police has expressed that all the OCs have been instructed to furnish mobile numbers of the investigating officers in the charge sheets. In addition to that the Superintendent of Police has assured that within next 2-3 days they will be providing a list of investigation officers (who left the station on transfer) along with their phone numbers for ensuring their timely appearance in Court during trial.
2. The Additional Deputy Commissioner has assured that steps for early appointment of G.P. will be taken from their end as new list of Addl. P.P.s and Asstt. P.P.s has already been received but G. P is yet to be appointed.
3. The Superintendent of Police informed that process of destruction of contraband of NDPS cases has almost completed except in 10 cases of Nagaon police station and they are taking steps for early completion of process.
4. In the meeting the Additional Deputy Commissioner, Nagaon assured that one appropriate place will be provided for separate Malkhana for keeping NDPS contrabands and further that they have identified the place and same will be finalized within next month.
5. The committee also discussed that the production of CCL shall be on time and case of any deviation shall be immediately brought to the notice of the Superintendent of Police.
6. The committee also discussed the status of pending NBWAs in all police stations in Nagaon District and delay occasioned in execution of processes for alteration in territorial jurisdiction of police stations and further agreed on the suggestion of redirection of processes to appropriate police stations within the District through the Superintendent of Police without forwarding the same to Court to avoid unnecessary delay.




