An urgent meeting of the I.C.T Committee, Nagaon, Assam was convened today at 3.30 PM in the office chamber of the District & Sessions Judge to discuss the following matters:

1. Discussion regarding requirement of computer accessories like web camera and speaker for enabling JITSi in order to court functioning through video conference.
2. Discussion regarding setting up of e-Seva Kendra.

After threadbare discussion, following resolutions were made against respective agenda items:-

Resolution No.1 :

The ICT committee discussed regarding the requirement of web camera, microphone and speaker for video conference facility for enabling virtual courts for all the courts of Nagaon District Judiciary including SDJM,Hojai and SDJM, Kaliabor and resolved that total 46 nos of camera and speaker are required . As the empanelled supplier for Nagaon District Judiciary informed that currently good quality web camera (Logitech with minimum standard specification) are not present in the market of Nagaon and as the requirement is very urgent the committee has resolved that the request may be made to the Hon'ble Gauhati High Court for provide these equipments centrally from Hon'ble High Court so as to enable VC facilities through JITSi for all Courts in Nagaon District Judiciary.





Resolution No.2:

After a detail discussion the committee has decided to call estimate from PWD for setting up e-Seva Kendra in suitable place in the court premises. Court Manager to take steps in this regard. The committee has resolved that a temporary e-seva Kendra may be setup with the resources available in the District court complex of Nagaon till the funds are allotted. The committee also instructed Systems Officer to take step for explore the feasibility of setting up of the said temporary e-seva Kendra with the help of Nodal Officer and prepare a list for the same.
