**ORDER No. DJN/ 1400**

**Dated 22.02.2022**

Pursuant to Notification No.11, dated 16<sup>th</sup> February 2022 issued by Hon'ble Gauhati High Court in view of the resumption of physical Courts and regulation of Bar rooms within the premises of the Subordinate Courts of Assam and in modification to all earlier orders, the following arrangements are hereby made for the functioning of district courts at Nagaon, Kaliabor and Hamren (West Karbi Anglong District). This order is subject to any further instruction issued by Hon'ble Gauhati High Court in this regard:-

1. Cases will be heard in physical mode and all types of cases will be listed. However, request for hearing of cases through video Conferencing may be allowed with prior approval of the presiding officer of the concerned Court.
2. Non-vaccinated/ partially vaccinated learned Advocates/ Court staff shall be permitted to enter the Court premises only after production of a Negative RT-PCR test report not older than 48 hours.
3. All fully vaccinated staff shall attend the office without fail.
4. Bar rooms shall be permitted to remain open by adhering to COVID-19 protocols issued by Hon'ble Gauhati High Court/ Government from time to time.
5. Litigants/ witnesses who have taken at least 1 (one) dose of COVID-19 vaccine shall be permitted to enter inside the Court premises on production of the COVID-19 vaccination certificate.
6. Wearing of face masks, maintaining social distancing, regular hand washing and use of sanitizer is mandatory inside the Court premises.
7. Seating arrangement inside the Court room shall be limited to 50%. The Presiding Officer of the concerned Court shall ensure that there is overcrowding inside the Court room.

8. Entry of any person, other than litigants, in connection with any important work inside the Court premises shall be allowed with prior permission of the Court Manager/ Chief Executive Officer/ Head Assistant as the case may be.
9. The canteen shall remain open by adhering to COVID-19 protocols issued by Hon'ble Gauhati High Court/ Government from time to time.
10. The above arrangements shall be applicable with immediate effect.
